"With all the animals who live in cages, and performers who live in caravans?" says the duck.

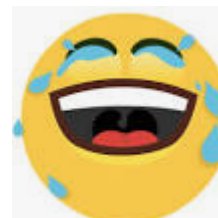
"Of course," the barman replies.

Poppy Appeal 2022

Planning is progressing nicely but we still require a lot more sellers. Check out the roster displayed at the RSL room to see where the blanks are and put your name in where you can or give Phil or Gary a call. Any time you can give will be greatly appreciated.

Our **GOAL** for the 2022 Poppy Appeal **is to attract more sellers.**

Remembrance Day 2022 is **Friday 11 Nov.** The Sunbury RSL Sub-branch will conduct Poppy Appeal Sales from **Friday 28 Oct until Friday 11 Nov.**

As previously reported, table sales will commence on **Fri 28 Oct.** Sales are normally conducted between 9am and 2pm (0900-1400) Mon to Sat, with Sundays optional. Split shifts are always welcome if you can't do a whole day. Sales on **Fri 11 Nov** will be coordinated with Remembrance Day services at the hall.

Sales will be conducted at the same 8 locations: Geyers, Evans St (outside Mowatts Butcher), Sunbury Square (outside SpendLess Shoes), Woolies and Big W (Sunbury Plaza), Target, Bunnings, and Rosenthal. EFTPOS machines have been requested again for Sunbury Square, Woolies, Bunnings, and Rosenthal. We have also requested an extra EFTPOS machine to be located at Target due to feedback from previous sellers.

We would like at least 2 people at each site for safety, to ensure sellers can take breaks and answer calls of nature as required, as well as redundancy if someone cannot attend at the last minute. We will also have the usual suspects roving between sites on most days annoying you, cracking the whip and restocking your trays.

Sunbury RSL

Sunbury News Saturday 2th September 1919

Bulla Shire Soldiers Memorial



The committee of the above request that the following list of soldiers connected with the Shire who enlisted and served with the A.I.F or actually went into camp and whose names are to be inscribed on the monument to be erected in Sunbury by Sir Rupert Clarke, in memory of his nephew Lieutenant Keith MacDonald be carefully examined, and that any omissions or inaccuracies be notified to the Secretary A.F Boardman, 'News' office, Sunbury at the earliest that the list should be an accurate record of all soldiers in any way connected with the shire.

Sunbury News Saturday 18th October 1919

The following sites were submitted for the handsome memorial to be erected by Sir Rupert Clarke.

- 1 In front of the Memorial Hall
- 2 Corner of O'Shanassy and Macedon Streets
- 3 Corner of Stawell and Macedon Gates
- 4 Opposite rupertwood Gates
- 5 Boulevards near the Sunbury Post Office
- 6 Corner of Church of England grounds facing Starkie Memorial

It was decided to select the site by exhaustive ballot, but NO 3 site (opposite State School corner in Macedon Street) was chosen on the first count by an absolute majority.

Sunbury News 6th December 1919

A meeting of the Sunbury Sub-Branch of the Returned Soldiers Association was held in the Mechanics Hall on Tuesday Night. Routine business was transacted. It was also decided to take part in the local peace celebrations.

Sunbury News Saturday 24th January 1920

The following Office Bearers were elected at the annual meeting of the Sunbury Sub- Branch of the Returned Soldiers Association

President: Dr W.A Morton (re-elected)

Vice-Presidents: Mr P Mullens, Mr R Gregor, Mr K McKenzie Secretary: Mr J. F Mounsey (re-elected)

Treasurer: Mr W Williams (re-elected)

Committee: Mr Rhodes, Mr Dawson, Mr McKinnon, Mr C Flintoft, Mr T Eagan, Mr W Deverall, Mr A Reace.



Dispatches October

Dawn October 26th, 1951

Eight seafury's catapulted off H.M.A.s Sydney in yellow sea—west of Korea.

Four lots of two—on missions of opportunities—in selected target areas.

Each armed with 8 rockets and 20mm cannons.

I flew with the squadron c.o. as his wing man. Ship to target area 12 minutes.

In target area; there were 4 hay stacks neatly parked—not there two days ago—the tracks of the vehicles were evident. (rice straw tanks)

First dive: we got two tanks with rockets.

On second dive: we used cannon. On 'pull up' I felt a big shake just as I was 'greying out' in the climb—usually lasts 5-10 seconds. At 1500 feet—all came back into focus: The left side of cockpit covered in oil—oil everywhere call c.o.—no radio. No good releasing cockpit escape panel: would get covered with hot oil—make a decision and stick to it. Tidal island in estuary—good slippery mud. All went well till left wing hit an embankment. I broke right strap of harness—knocked myself "out".

About two minutes later; I "came too": heard aircraft of c.o.; got signal flag out: let c.o. know I was ok.

We were issued with two flags—one yellow and one red. If you are ok wave the yellow : if you are injured or dead wave the red flag. (work that one out)

I spent the next six hours under a pine tree: within sight of the wrecked seafury. About 3pm I heard a motor boat (cutter) it stopped right opposite me. I stayed hidden: Then a great cockney voice: "Where are you??"

"Rescued" - taken out to H.M.S. Amethyst. Where I stayed for 4 days on their patrol; And eventually deposited back to H.M.A.S. Sydney in Kure Japan

AUSTRALIA 1982

Dispatches October

February

2 February – Lindy Chamberlain is committed for trial for the murder of her daughter Azaria.

5 February – A Cessna 411A aircraft crashes into a building at Archerfield Airport. The pilot and four people within the building are killed.

March

20 March – Thousands of people walked across the Sydney Harbour Bridge to mark its 50th anniversary.

April

3 April – After almost 27 years in power, the Liberal/National coalition government is voted out in Victoria & is replaced by the ALP

11 April – Business entrepreneur and adventurer Dick Smith makes a record solo helicopter flight from Sydney to Bundaberg.

16 April – Archbishop John Grindrod is appointed as Anglican Primate of Australia, succeeding Sir Marcus Loane.

19 April – Federal Health Minister Michael MacKellar and Customs and Excise Minister John Moore resign over Michael MacKellar's failure to declare and pay duty on a colour television set in October 1981.

July

7 July – The Australian Labor Party reverses its policy on uranium mining to allow for the continuation of existing projects.

16 July – In response to a leadership challenge by Bob Hawke (which came to a head during the Australian Labor Party National Conference), Bill Hayden resigns, and in a secret vote, retains the leadership by a close 42:37.

29 July – Sir Ninian Stephen succeeds Sir Zelman Cowen as Governor-General of Australia.

August

2 August – The Daily Sun newspaper begins publication in Brisbane.

8 August – The Dalai Lama visits Australia to mark the 30th anniversary of the establishment of Buddhism in the country.

15 August – Queensland Government workers, including railway employees, walk out for two days in support of shorter working hours and a general strike results.

24 August –

The fourth interim report of the Costigan Royal Commission into the Ships Painters and Dockers' Union begins a series of revelations about tax fraud which implicates senior public servants and members of the Liberal Party. The report highlights tax-avoidance schemes, including "bottom of the harbour" plans. The resulting furor ends speculation about an early election.

The strike in Queensland ends when unions capitulate before the government's adamant attitude on the issue.

October

11 October – Andrew Peacock becomes Industry and Commerce Minister after 18 months on the backbench when ill-health forces Sir Phillip Lynch's resignation from the position and from Parliament.

12 October – Elizabeth II officially opens the new building of the National Gallery of Australia in Canberra.

The South Melbourne Swans move to Sydney & become the Sydney Swans.



25 September – Carlton Blues (14.19.103) defeat the Richmond Tigers (12.13.83) to win the 86th VFL premiership. It is the second consecutive premiership for Carlton & the last grand final appearance for 35 years for Richmond.

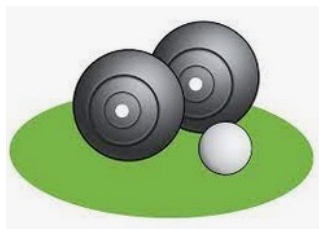


30 September – 9 October – The 1982 Commonwealth Games are held in Brisbane, Queensland



2 November – Gurner's Lane wins the Melbourne Cup.

The bartender says "I'm sure it's none of my business, but where did you find a little man who plays piano like that?"

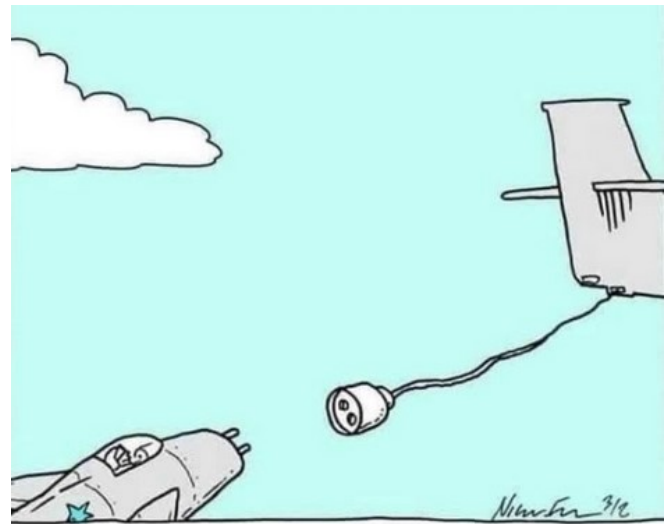

One-pan chicken drumsticks

try me



1.2kg (about 9) chicken drumsticks, skin scored

1 tbsp extra virgin olive oil

150g (1/2 cup) white miso paste(soy sauce or fish sauce good substitute 0

80ml (1/3 cup) mirin (like sake bit less alcohol more sugar 0

2 tsp low-salt soy sauce

2 tsp caster sugar

1 1/2 tbsp finely grated fresh ginger

200g (1 cup) brown basmati rice

500ml (2 cups) chicken style liquid stock

Kale leaf and spinach mix, to serve

Sliced green shallot, to sprinkle

Step 1

Preheat oven to 220C/200C fan forced. Place the drumsticks in a single layer in a large baking dish. Drizzle with the oil . Season. Bake for 20 minutes or until the drumsticks are starting to brown.

Step 2

Meanwhile, combine the miso , mirin , soy sauce , sugar and ginger in a small jug.

Step 3

Use tongs to turn the drumsticks. Sprinkle the rice between them. Pour over the stock and 375ml (1 1/2 cups) water. Drizzle the drumsticks with the miso mixture. Bake for a further 30-40 minutes or until the drumsticks are golden and cooked through, and the liquid is absorbed. Set aside for 5 minutes to rest. Sprinkle with kale mix and shallot .
